<b>1. New Residential Buildings</b> – The following fees shall include all wiring and electrical equipment in or on each building, or other electrical equipment on the same premises constructed at the same time.			
	* <b>Multifamily</b> – For new multifamily buildings (apartments and condominiums) having three or more dwelling units constructed at the same time, not including the area of garages, carports and accessory buildings, per square foot (0.09 m <sup>2</sup> ).	\$0.050	
	* <b>Single and Two-family</b> – For new single- and two-family residential buildings constructed at the same time and not including the area of garages, carports, and accessory buildings, per square foot (0.09 m <sup>2</sup> ).	\$0.056	
	<b>2. Private Swimming Pools</b> – For new private, in ground swimming pools for single-family and multifamily occupancies, including a complete system of necessary branch circuit wiring, bonding, grounding, underwater lighting, water pumping and other similar electrical equipment directly related to the operation of a swimming pool, each pool.	\$49.50	
<b>3. Carnivals and Circuses</b> – Carnivals, circuses, or other traveling shows or exhibitions utilizing transportable-type rides, booths, displays, and attractions.			
	* For electrical generators and electrically driven rides, each	\$23.50	
	* For mechanically driven rides and walk-through attractions or displays having electric lighting, each	\$7.25	
	* For a system of area and booth lighting, each	\$7.25

	<b>4. Temporary Power Service</b> – For a temporary service pole or pedestal, including all pole or pedestal mounted receptacle outlets and appurtenances each.	\$23.50

Residential Appliances</b> – For fixed residential appliances or receptacle outlets for same, including wall-mounted electric ovens; counter-mounted cooking tops; electric ranges; self-contained room; console or through-wall air conditioners; space heaters; food waste grinders; dishwaters; washing machine; water heaters; clothes dryers; or other motor-operated appliances not exceeding 1 horsepower (HP) (746 W) in rating, each (For other types of air conditioners and other motor-driven appliances having larger electrical ratings, see Power apparatus)	\$4.75	
	<b>4. Nonresidential Appliances</b> – For nonresidential appliances and self-contained factory-wired, nonresidential appliances not exceeding 1 horsepower (HP), kilowatt (kW) or kilovolt-ampere (kVA), in rating, including medical and dental devices; food, beverage and ice cream cabinets; illuminated show cases; drinking fountains; vending machines; laundry machines; or other similar types of equipment, each (For other types of air conditioners and other motor-driven appliances having larger electrical ratings, see Power apparatus)	\$4.75	
<b>5. Power Apparatus</b> – For motors, generators, transformers, rectifiers, synchronous converters, capacitors, industrial heating, air conditioners and heat pumps, cooking or baking equipment, and other apparatus, as follows: <i>Rating in horsepower (HP), kilowatts (kW), kilovolt-amperes (kVA) or kilovolt-amperes-reactive (kVAR):</i>

**Inspection Requests:** It shall be the duty of the holder of the building permit or their duly authorized agent to notify the Building & Safety Department when work is ready for inspections.

- Inspections should be scheduled and recorded before 5:00 p.m. the day before the inspection is requested.
- After Hours, Weekend and Holiday Inspections should be scheduled and the appropriate fee must be paid at least two-days before the required inspection date.
- All inspections should be called in and recorded using the County Inspection Request Message System (CIRMS) at (712) 527-4347.
- A.M. scheduled inspections will be performed from 8:00 a.m. to 12:00 noon.
- P.M. scheduled inspections will be performed from 12:00 noon to 4:00 p.m.
- Any special requested inspection time will need to be pre-approved by your scheduled Inspector, the day before.
