

MILLS COUNTY ATTORNEY
DRIVER'S LICENSE REINSTATEMENT PLAN (CAPP)

◆ APPLICATION:

Many issues may affect your driver's license. CAPPs deal only with suspensions for unpaid fines and DOT civil penalties.

Applicants who have other license issues must address them before participating in a CAPP. General information about how to deal with those issues is on the other side of this page.

Applicants must complete a financial disclosure statement.

Applicants with pending criminal cases in Mills County will not be considered for participation until those charges have been resolved.

Acceptance or refusal of an applicant into the program is subject to the full discretion of the Mills County Attorney's Office.

◆ PARTICIPATION

Participants must promptly update the County Attorney's Office of all changes of address, phone numbers and jobs throughout the life of the plan.

Participants must make regular payments throughout the life of the plan.

- Participants with jobs must sign wage assignments for all jobs they hold throughout the life of the plan.
- Wage assignments will include all debts owed to the court in Mills County.
- Unemployed participants will be responsible for making payments without reminders from the County Attorney's Office.

Participants must maintain and provide proof of motor vehicle liability insurance throughout the life of the plan.

- Participants who do not own a motor vehicle must either
- maintain a "non-owner's" insurance policy, OR
 - be a named driver on a policy that covers the vehicle the participant will be using.

Participants must sign a release of information allowing the County Attorney to verify continuing coverage directly with the insurer or insurance agent.

First payment is due at the time the CAPP is filed. Money orders, cashier's checks and cash in person are acceptable forms of payment. The Clerk of Court will not accept personal checks.

- Debit and credit cards may be used only after DOT civil penalties have been paid.

After your plan is filed, allow AT LEAST two weeks for the DOT to clear the suspensions on your license – BE PATIENT.

OTHER LICENSE ISSUES

Suspensions:

Unpaid child support.

- Must be addressed with Child Support Recovery before a CAPP is filed.
- Child support obligations must remain current throughout the life of the CAPP.

12-hour Drinking Driver's class.

- Iowa's community colleges offer this for about \$115.00.
- If you live out-of-state go to www.iowa.gov/educate/OWI or call (515) 281-5251.
- If you already took the class, contact your provider and ask them to notify DOT.

Substance Abuse Evaluations.

- Finding a provider: Look in the yellow pages under "Drug Abuse" or "Substance Abuse" or call your local probation department for a list of local providers.
- If you already finished treatment, contact your provider and ask them to notify DOT.

Civil Judgments:

- Arrange a pay plan with the person who sued you. They must notify the DOT you have done this.

Unpaid out-of-state fines.

- Cannot be included in a CAPP.
- Must be paid in full before a CAPP will be filed.

Barred or Revoked:

- Only time will end these license penalties.
- Maintaining a CAPP might allow you to apply for a restricted license for work or school while your bar or revocation runs its course.
