	<ul style="list-style-type: none"> <li>● <b>Single and Two-family</b> – For new single- and two-family residential buildings constructed at the same time and not including the area of garages, carports, and accessory buildings, per square foot (0.09 m<sup>2</sup>).</li> </ul>	\$ 0.056	
	<b>2. Private Swimming Pools</b> – For new private, in ground swimming pools for single-family and multifamily occupancies, including a complete system of necessary branch circuit wiring, bonding, grounding, underwater lighting, water pumping and other similar electrical equipment directly related to the operation of a swimming pool, each pool.	\$49.50	
<b>3. Carnivals and Circuses</b> – Carnivals, circuses, or other traveling shows or exhibitions utilizing transportable-type rides, booths, displays, and attractions.

- Inspections should be scheduled and recorded before 5:00 p.m. the day before the inspection is requested.
- After Hours, Weekend and Holiday Inspections should be scheduled and the appropriate fee must be paid at least two-days before the required inspection date.
- A.M. scheduled inspections will be performed from 8:00 a.m. to 12:00 noon.
- P.M. scheduled inspections will be performed from 12:00 noon to 3:00 p.m.
- Any special requested inspection time will need to be pre-approved by your scheduled Inspector, the day before.
